INVITATION

The Grootfontein Show Society hereby invites churches and schools only to submit tenders to operate the Namibia Breweries Beer Tent during the three official show days of the Grootfontein Show 2026. This is a fundraising opportunity, and the selected tenderer will be allowed to keep all profits, subject to the following terms and conditions:

ELIGIBILITY & AWARD

- Only churches and schools may apply.
- The Show Committee reserves the right to award the tender to any party they deem suitable, regardless of the financial offer made.

DEPOSIT

- A refundable deposit of N\$4,000 is payable upon confirmation of tender approval.
- The full deposit will be refunded after the show if no losses or damages to the equipment occur.

EQUIPMENT AND RESPONSIBILITY

- Namibia Breweries will sponsor and supply the following:
 - A large tent
 - Tables and benches
 - Fridges
- The tenderer must sign for all equipment received.
- The tenderer is liable for any losses, theft, or damages to the provided equipment. If any claims are made, the insurance excess will be deducted from the deposit.
- The tenderer is responsible for the offloading of the tent and equipment from the delivery vehicle, for erecting and dismantling the tent, and to load everything back onto the vehicle after the event.

ACCESS AND ENTRY PASSES

- No entry tickets are included in this tender.
- All access to the show grounds for workers, organisers, and vehicles must be arranged and paid for by the tenderer.
- A complete list of all individuals requiring entry passes must be submitted by Friday, 11 September 2026.

ALCOHOL SALES ONLY

Only the sale of alcoholic beverages is permitted.

No food sales are allowed from the beer tent.

The tenderer is responsible for:

1. Purchasing and managing their own beverage stock
2. The Show Society is responsible for securing a valid liquor license
3. Ensuring all sales comply with national and local laws

SECURITY

- While general event security is provided on the showgrounds, the tenderer is responsible for the security of their own equipment and stock.
- The Grootfontein Show Society accepts no responsibility for any losses or damages incurred.
